JOINTLY DEVELOPED

Shoal Creek Elementary will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

- Shoal Creek Elementary (SCE) will involve parents in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parental involvement policy and the joint development of the school-wide program under Section 1114(b)(2) of the Elementary and Secondary Education Act of 1965 (ESEA). ANNUAL TITLE I MEETING

Shoal Creek Elementary will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school Parent and Family Engagement Plan, the schoolwide plan, and the School-Parent Compact.

- Parents are involved in the decisions regarding how funds reserved are allotted for parental involvement activities. Parents are provided multiple opportunities to provide input on the 1% set-aside funds the school receives for parent and family engagement opportunities. COORDINATION OF SERVICES

Shoal Creek Elementary will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents more fully in the education of their children by:

- SCE will coordinate and integrate parent involvement programs, activities, and strategies as much as possible with our Kindergarten Transition Team and Homeless Liaison. For example, the Kindergarten Transition Team will work closely with area daycare facilities to provide resources and services for parents. Parents will be invited to attend a parent workshop to learn about Kindergarten Reimagined prior to the beginning of school. Parents will be provided with materials and directions to assist them with preparing their child for the transition to school.

BUILDING CAPACITY OF PARENTS

Shoal Creek Elementary will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum used at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards;

- A minimum of four (4) parent workshops will be provided for parents during the school year. Topics for these workshops will be based on student and parent needs. Part of these training opportunities will include strategies that parents can use at home to reinforce literacy skills. Parents will be provided with several resources, including technology, and tools to utilize in the home setting. The School Counselor, Instructional Coach, and teachers are available to provide support and academic help skills to parents. Instructional materials and literature about how to help children succeed in school are always offered to check out from the Parent Resource Center.
- Parents are provided with written documentation about the State curriculum in the fall and as requested throughout the school year. Parents are provided assistance interpreting the County's standards-based grading system and report cards. Parent/Teacher conferences will be an arena in which parents will be given additional assistance with understanding student performance levels.
- Parents will be provided with the types of assessments, formal and informal, that will be administered to students during the school year. They will be given specific information used in measuring student progress and the expectations for meeting and exceeding State standards. The names and descriptions of State and local assessments will be provided to parents. They will receive further assistance at parent/teacher conferences. Letters will also be sent home with information about the assessments being administered, as well as an interpretation of the assessment results.

BUILDING CAPACITY OF SCHOOL STAFF

Shoal Creek Elementary will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- SCE will provide training to educate the teachers, pupil services personnel, principal, and other staff on how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs, and build ties between parents and the school. Staff training will be provided at least four times per year to staff during grade level meetings, staff meetings and online videos and communications from the Parent Liaison.

POLICY COMPONENTS

- Involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.
 - Parents will be notified of any community resources that will assist them to become full partners in the education of their children. The school's partners-in-educations sponsors and the PTA will be encouraged to assist parents. The school staff will provide academic assistance to students through the after-school tutorial program. Staff members will be trained in working with parents and how to meet their needs while working with students. Parent feedback will be sought through various avenues in making staff members aware of assistance that is needed. The Parent Liaison will also offer support for new families enrolling at Shoal Creek.
- Parent suggestions will also be included in planning professional learning for the administration, faculty, and staff members. Every effort will be made to strengthen the partnership between school and home as staff members seek ways to communicate with parents and improve the school community.

 - As part of the school's Strategic Plan, staff members and parents will form a Parent-to-Parent Team with the purpose of designing ways to involve parents in the school, especially parents new to the school.
